Application Check List

- Completed Dealer Application (page 2)
- Federal Tax ID
- Copy of State Resale Tax Certificate
- No less then three trade references from the Construction Equipment Industry
- One photo of your storefront
- Two photos of your current inventory
- Minimum first time order of \$500.00

Once the above documentation is submitted the dealer application will go through an approval process. Allow up to five (5) business days for dealer approval.

Payment Terms

New customers may charge their orders on a VISA, MasterCard or COD. Customers requesting a Net 30 account must submit a completed credit application. Credit applications are available upon request. Please allow two (2) weeks for your credit application to be processed and your account opened.

Pricing Structure

- o **Retail Group:** A customer that is not dealer eligible. This is the price level used until a customer is approved for dealer pricing.
- o **Wholesale Group:** A dealer eligible customer with less than \$10,000 annual purchases.
- o **Premium Group:** A dealer eligible customer with \$10,000 greater annual purchases.

Damaged Shipments & Shortages

If parts are damaged and or lost in shipping do not destroy packaging until the freight carrier has inspected the package. On truck freight shipments please check your shipments before signing the bill of lading. For claims of lost or damaged parts contact our customer service department within 10 business days of the receipt date of goods.

Product Returns

Prior to returning parts for any reason, you must contact our sales department to obtain a Return Merchandise Authorization (RMA) number. Returns without a RMA number will not receive credit. The return must be sent back freight prepaid with the RMA number clearly marked on the outside of the package. All returned parts will be evaluated and must be in new and resale condition to receive credit. Items returned after 30 days are subject to a 15% restocking fee. No returns are accepted after 90 days. Returned hydraulic cylinders are subject to an additional \$50.00 repainting fee.

Cores

Please inspect your cores before returning them for credit. . All cores will be evaluated and must be in rebuildable condition to receive full core value. Any cores not returned within 60 days are subject to receiving only 2/3 core value. Freight on core returns is at the customer's expense. Please include RMA numbers on all cores to receive credit.

Warranty

Paint Valley Equipment has a 90 day warranty on new and rebuilt products against defects in materials and workmanship at the time of shipment. The exclusive remedy is replacement of defective products, or, at our option, refund of their purchase price. All damages exceeding the purchase price are excluded, whether consequential or otherwise, regardless of cause.
